The fund aims to provide long term growth whilst investing in a diversified portfolio of assets (including equities, fixed interest and property) in order to reduce the risk associated with being solely invested in any one asset class. These assets can be from both the UK and overseas. The proportions held in each asset class will typically be re balanced on a monthly basis to the long term strategic asset allocation of 70% in equities and property and 30% in bonds, cash deposits and money market instruments.

The fund may use derivatives for the purposes of efficient portfolio management, reduction of risk or to meet its investment objective if this is permitted and appropriate. 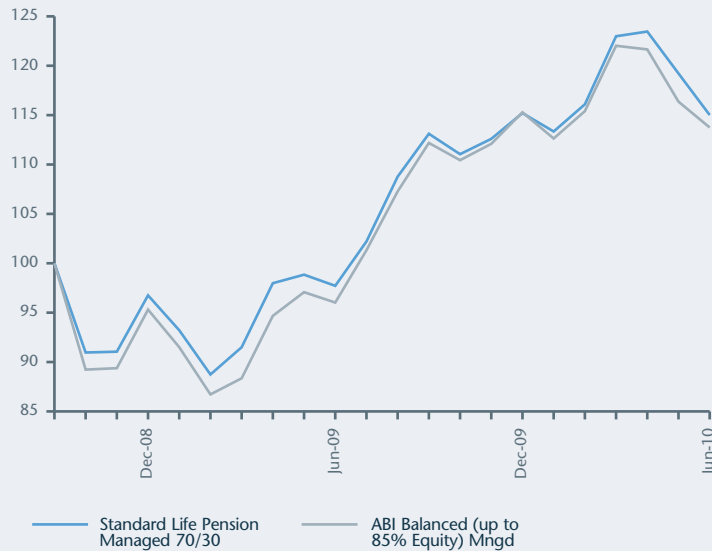
