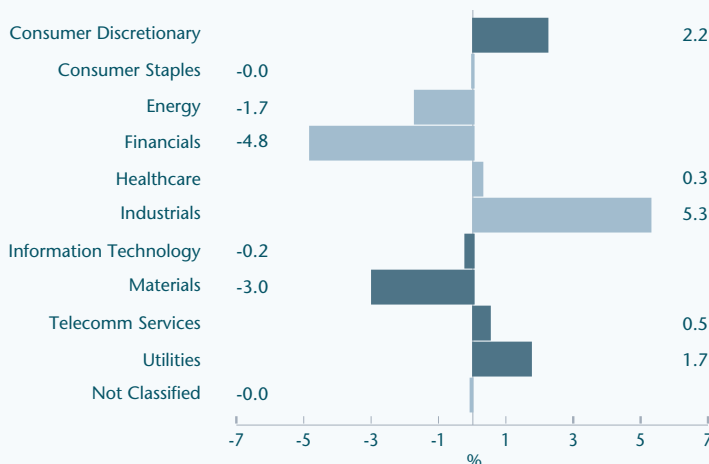

Sector Positions Relative to Index as at 30 June 2010

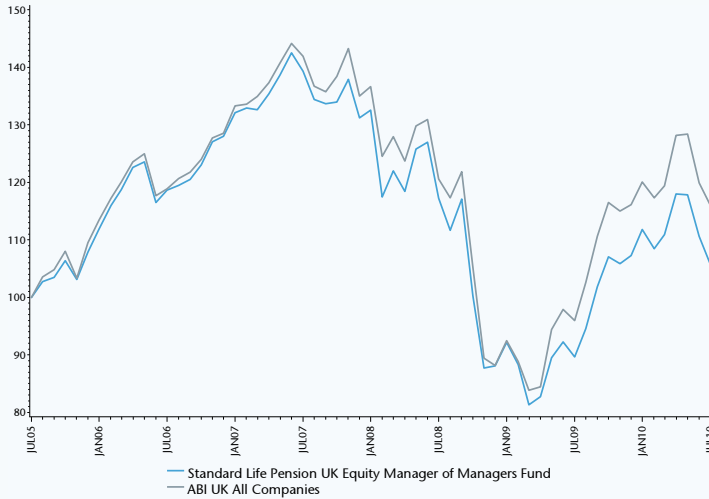
